CIF PROCEDURE

- 1. Buyer issues ICPO must be with buyer company letterhead and buyer banking information.
- 2. Seller issues Draft Contract (open for any amendments) to Buyer. Buyer signs, seals and returns the Draft Contract to Seller with RWA letter for final endorsement, Seller gives Partial proof of products
- (A) Refinery Commitment to Supply
- (B) Certificate of Origin
- (C) Statement of availability of product
- (D) Product transportation contract, to load the product from the reservoir to tank at port of loading,
- (E) Pre injection report from reservoir to tank at port of loading.
- 3. Upon buyer successful SOP/verification and in order to confirm the buyer capability and seriousness, buyer and seller jointly contact a reliable shipping company and jointly pay 50% cost to the shipping company to secure the vessel in favor of the buyer and this payment is 100% deductible out of the total cost of product.
- 4. Seller settle all fee in the port and load the vessel at his own cost and immediately provide all shipping documents below to the buyer
- a) Copy of Vessel Questionnaire 88.
- b) Copy of Bill of Lading.
- c) Dip test Authorization (DTA) & ATB
- d) NOR /ETA
- e) Certificate of Ownership Transfer
- 4. Shipment commences as per signed contract delivery schedule and the shipment should arrive at Buyer's discharge port within
- 5-20 days maximum. The SGS inspection will be borne by the Seller at the loading seaport and Buyer at the unloading seaport
- 5. Buyer releases payment to Seller by TT/MT103 upon receipt of the shipping documents and confirmation of the Q & Q by SGS/CIQ at destination port.
- 6. Seller pays commission within 48 hours by swift MT103 to all intermediaries as signed NCNDA/IMPFA.

TTO TRANSACTION PROCEDURE (SPOT)

- 1. Buyer issues an official ICPO with acceptance letter and company registration certificate.
- 2. Seller issue buyer MOU with past performance sanitize shipping documents of any product, buyer sign back the MOU and confirm the past performance document,
- a. Commercial Invoice
- b. Product Passport
- c. Analysis test report
- d. Certificate of Origin
- e. Bill of Lading
- f. Vessel Notice
- g. Cargo Manifest
- h. Vessel Q88
- 3. Buyer pays 5% from the total product value as procurement guarantee to Sellers nominated bank by MT 103 /TT within 48 hours of receiving the above documents also this payment will be deducted out of the total cost of product.

- 4.
