PROCEDURE: FOR TANKER TAKE OVER TTO PROCEDURE.

- (1) BUYER ISSUES IRREVOCABLE CORPORATE PURCHASE ORDER (ICPO) ACCORDING TO SELLER PROCEDURE.
- (2) SELLER ISSUES MOU AND ICC WARNING LETTER FOR BUYER TO SIGN AND RETURN BACK WITH GUARANTEE LETTER SIGN AND SEALED ON THE BUYER COMPANY LETTER HEAD.
- (3) SELLER REGISTER /LEGALIZED MOU AND ISSUES THE FOLLOWING DOCUMENTS:
 - (A) PRODUCT PASSPORT
 - (B) COMMITMENT LETTER TO SUPPLY
 - (C) STATEMENT OF AVAILABILITY OF THE PRODUCT IN RESERVOIR
 - (D) CERTIFICATE OF ORIGIN OF THE PRODUCT
 - (E) CHANGE OF OWNERSHIP TITLE PAYMENT INVOICE
 - (F) TANK RECEIPT.
- (4) BUYER RECEIVED DOCUMENT AND PROCEED ON THE OWNERSHIP PAYMENT.
