TRANSACTION PROCEDURE FOB ROTTERDAM DIP AND PAY

- 1. Buyer issues ICPO, company profile, Buyer's passport copy data, TSA and letter of acceptance stating to adhere to seller's transaction terms and procedure.
- 2. Seller issues commercial invoice CI to buyer to countersign, Attestation of product availability and Supply Approval License &ICC Warning Letter from ICC.
- 3. Seller releases Fresh SGS less than 48 hours old; the seller through their Tank logistic company where the product is stored will physically present fresh SGS less than 48hrs to buyer tank farm logistic company only to verify product SGS Report.
- 4. Buyer provides his Tank Storage Receipt from his tank farm company or extend seller's tank to conduct dip test in seller tank with SGS (or equivalent) officials and receives fresh SGS report not less than 24 hours alongside ATSC (Authorization to Sell and Collect) on Buyer's name and leased tank information including the POP documents.
- 5. within 72hours, seller commence injection of the product into buyer's tank.
- 5. Upon successful injection into buyer tanks, seller provides injection report to buyer and buyer pays total cost of product via MT103.
- 6. Seller confirms payment receipt and both parties release payment to all intermediaries on each side involved inthe transaction.

OFFICIAL TRANSACTION PROCEDURE FOR COST INSURANCE FREIGHT

- 1. Buyer issues ICPO must be with buyer company letterhead, passport copy and company registration certificate.
- 2. Seller issues Draft Contract (open for any amendments) alongside International Criminal Court for the Prevention of Disregards and Breach of Contract (ICC) three party agreement, to be endorsed by all three parties; this agreement is a guarantee to adhere to the terms of the contract. Buyer signs, seals and returns

- 4. Seller furnishes to buyer the legalized MOU and the following documents for buyer's confirmation.
 - A. Seller's Export License/Registration Certificate
 - B. Bill of Lading (in the name of previous buyer as Consignee)
 - C. Vessel tanker details (IMO number).
 - D. Product Passport-Dip-Test Report
 - E. Proforma Invoice
 - F. Transaction guarantee deposit Invoice of \$985,000.00 United States dollar into seller's nominated offshore bank account
 - G. Cargo Manifest
 - H. Cargo Ullage Report.

- 5. - 8. Upon the successful completion of Dip-test inspection, buyer make the balance payment by MT103 wire transfer for the total product value; seller transfers Title of ownership Certificate to the buyer's name as the legitimate owner of the product and commence trans loading immediately.
