- The seller issues to the buyer the POP documents listed below on receipt of the signed commercial invoice from the buyer:
  - TSR
  - Dip Test Authority (DTA)
  - ATV
  - ATSC
  - Injection report.
- Buyer extends seller's tank, to conduct dip test in seller's tank with SGS, and commences injection into buyer's tank or vessel. buyer will receive a copy of the fresh SGS report within 24 hours alongside ATSC (Authorization to Sell and Collect) on buyer's name and leased tank information. The buyer or buyer representative is required to be present while the process is on (COMPULSORY).**
- Within 48 hours, the buyer pays 30% of the total cost of the product via MT103. Upon a successful dip test and conformation of the sgs, Seller commences the injection of the product.
